The letter agreement between RWA Foundation and Genesis Trading accomplishes the following:

- 1. Creates a legally binding obligation of the exchange broker to convert DAI received from the vault into USD and transfer the USD to the escrow account held by Wilmington Savings Fund Society
- 2. Creates a legally binding obligation of the exchanger broker to convert USD received from the escrow account into DAI and transfer the DAI to RWA Jar.
- 3. Obligates the exchange broker not to accept any change to the destination of USD (i.e., escrow account) or DAI (i.e., RWA Jar) without Maker governance approval via an executive vote; provided that, Ankura Trust Holdings may change the destination for the DAI to RWAUrn. [Note: This change will occur after Maker governance determines to dissolve the Trust.]
- 4. The exchange broker recognizes that Ankura Trust Company will be the custodian of the username, password and secondary authentication for RWA Foundation portal access with the exchange broker.

Ankura Trust

The Ankura Trust letter agreement sets forth Ankura Trust's services and fees. The services include: review of each proposed loan participation (calculation agent), roll-up of the various value chain transactions in a report (crypto servicer), agent to receive notices for RWA Foundation under the various agreements, and custodian of the username, password and secondary authentication for RWA Foundation portal access with the exchange broker.

On July 12, 2022, RWA Master Participation Trust entered into a Master Participation Agreement (the "Agreement") with Huntingdon Valley Bank, a Pennsylvania chartered bank, acting as "Seller" and RWA Master Participation Trust acting as "Buyer."

Reference is made to the Articles of Association (the "Articles") of the RWA Foundation, pursuant to which RWA Foundation's operations are governed.

This resolution sets out the instructions and ratifications duly passed as an executed vote on
