2. Bad tokenomics models.



Choose your Captain

Get glorious Captains for your ships from the limited collection. The Captain will give you access to GRVS + GRVX farming pools.

Build your ship

Open lootboxes to find a ship or a building parts container. You can combine building parts to create a ship. Also, you can combine ships into more powerful ones.

Upgrade your gear

You can enhance ship's mining abilities by adding custom parts like Titanium Drill or Dark Matter Engine. These parts can be crafted from collected metal.

Launch!

Once everything is settled, stake your chosen NFT cards to the Mining contract to start your expedition. You can send as many ships as you want.

Trade

Buy or sell any parts, ships, skins or even Captains. Some ships and skins are very rare, and the Captains are released only once.

Choose your Clan

Obtain clan mark to join a Clan. Earn great rewards together with your clanmates against formidable bosses or in Clan Wars.

Progress through missions and earn ranks

Missions with different mechanics - exploration, battles, trading. Special missions for Captains and other characters.

Become a space mogul

Rent asteroids for profit yield, craft your own loot boxes for sell, build space stations to harbor other players and more.


