



Re: Withdrawal Set of Rules (OFFICIAL ANNOUNCEMENT)

Dearest **Team Members** & **Early Investors**,

First of all, I want to personally thank you for your invaluable support during the last couple of years. It has not been easy to cope with everyday life, anywhere in the World, with all this COVID-19 pandemic, as well as with the collateral damages produced by the war in Ukraine. Oil & gas prices have skyrocketed since; food prices are slowly having huge increments; the cryptoasset markets have been bearish during $\frac{3}{4}$ of year 2022; several crypto projects have died completely, and many others have gone broke. Nevertheless, we are still here, stronger than ever, ready to start a truly financial warfare within a **deflationary gamified NFT-based DeFi ecosystem: DeFiWars Finance**.

Taking into consideration the fact that you are either, **a. A Team Member** (e.g., you have an individual \$DWARF shareholding allocation, in exchange for doing the corresponding tasks in accordance with *DeFiWars Finance's* Strategic Planning workflows); **b. An Early Investor** (e.g., you have bought your \$DWARF allocation during the Seed Capital phase); or, **c. A Whale** (e.g., you have bought your \$DWARF allocation during the Private Sale phase, and currently hold more than 100,000 \$DWARF in your wallet), the following set of rules apply to you, as follows:

LIMITATIONS TO WITHDRAWALS FROM PANCAKESWAP LIQUIDITY POOL

1. The only official *PancakeSwap* Liquidity Pool shall be this: <https://pancakeswap.finance/add/0x33C29af05cA9aE21D8e1bf01Ad5adeFE7b2EE5Ff/BNB>.
2. If your \$DWARF allocation is subject to a vesting period (e.g., either you are a *Seed Capital Investor*, or a *Team Member*), **you may not withdraw any liquidity from the pool, until the vesting period has fully ended** (by September 22nd., 2023). Additionally, you will have to abide by the **Withdrawal Set of Rules** (below), where applicable.
3. If your \$DWARF allocation is NOT subject to a vesting period (e.g., either you are a *Private Sale Investor*, a *Public Sale Investor*, or a *Reward Beneficiary*), **you may withdraw up to 2% (TWO PERCENT) of your provisioned liquidity position, from the pool, once per day, until the Beta Release has been officially launched** (by Q2-2023). Additionally, you will have to abide by the **Withdrawal Set of Rules** (below), where applicable.



WITHDRAWAL SET OF RULES

Section (1). Any person who has a claim to a corresponding individual \$DWARF shareholding allocation, as part of any kind of agreement directly made with DeFiWars Finance's *Founder*, to perform any kind of personal or professional tasks from the project's workflows –mainly managed over the appropriate and corresponding Trello boards–, shall be considered as a **Team Member**.

Section (2). Any person who has a claim to a corresponding individual \$DWARF shareholding allocation, as part of any kind of sale event during the *Seed Capital* phase, and is *not a Team Member*, shall be considered as a **Seed Capital Investor**.

Section (3). Any person who has already claimed a corresponding individual \$DWARF allocation, as part of any kind of event during the *Private Sale* phase, and is *not a Team Member*, shall be considered as a **Private Sale Investor**.

Section (4). Any person who has already bought \$DWARF, either during a *Liquidity Auction*, or at DeFiWars Finance's official third-party *DEX* (any decentralised exchange where \$DWARF is officially listed) liquidity pool, shall be considered as a **Public Sale Investor**.

Section (5). Any person who has been awarded with any amount of \$DWARF, either from being selected as a winner of any contest or giveaway been held at any of the official DeFiWars Finance's social media channels, or as an additional incentive to perform any kind of specific task (e.g., *Ambassador*, *Shiller*, *Moderator*), shall be considered as a **Reward Beneficiary**.

Section (6). **Team Members** and **Seed Capital Investors** have their corresponding \$DWARF shareholding allocations *vested for a 12-month forceful period*. During that term, they both shall be able to collect their corresponding *quarterly distribution* of \$DWARF's total allocation, in terms of the *Seed Capital* phase terms & conditions, or the agreement individually made upon with DeFiWars Finance's *Founder*, depending on the case.

The rules for withdrawal set forth in this document, are especially binding to persons pertaining either to the **Team Members**, or to the **Seed Capital Investors** groups of people, as defined in sections (1) and (2), respectively.

Section (7). **Private Sale Investors**, **Public Sale Investors**, and **Reward Beneficiaries** are not subject to a vesting period. Nevertheless, if any individual belonging to one of these groups is hereby considered as a *Whale* (holds more than 100,000 unlocked \$DWARF), these rules shall be enforced too, where applicable.

Section (8). **Individual Monthly MAWA (Maximum Available Withdrawal Amount) shall always be less than 2% (TWO PERCENT) of its corresponding wallet's currently unlocked (e.g., unvested) \$DWARF token holdings, until a new MAWA is officially announced; any amount higher than this, is hereby forbidden.**

Individual Monthly *MAWA* will remain unchanged, until *Beta Release* has been officially launched, and a new *Set of Withdrawal Rules* has been duly published.

Section (9). Any person falling into one or more of the aforementioned groups, who in any way breaches the Individual Monthly *MAWA* –as disclosed in *Section (8)* of these terms–, on any given month, shall be sanctioned with a **temporary freeze** of his/her \$DWARF unlocked holdings. Such asset freezing shall never last less than 30 days. If the same person breaches *section (8)* again, the freezing will last for a full quarter, or until the *Beta Release* has been officially launched –whatever comes first–, and a new *Set of Withdrawal Rules* duly published.

Section (10). Further sanctions shall be applied to individuals who breach the rules herein contained, depending on to which group they pertain, abiding to the general **Terms & Conditions** duly published to that effect over *DeFiWars Finance's* official social media channels, and to be made available at its *Landing Page*.
