

## COVER ART OWNERSHIP

i. When you purchase your ART BLESS AMERICA NFT, ownership is transferred to you on the Polygon multi-chain network. A purchase of this NFT, constitutes ownership of the underlying ART BLESS AMERICA cover ART, for that individual piece of ART combination of traits and number. Ownership of each NFT is governed by the Polygon network terms and its associated Smart Contract. As such Digital-Galactic, LLC has no ability to alter the ownership or transaction of any ART BLESS AMERICA NFT.

ii. Personal Usage. Subject to perfect and continued compliance with these Terms, Digital-Galactic, LLC extends NFT holders worldwide, royalty-free license to use, copy, and display the purchased Art, along with any derivative artworks that you created or use, all of which are limited to the following purposes: (i) for your own personal, non-commercial use; (ii) as part of a marketplace that permits the purchase and sale of your ART BLESS AMERICA / NFT, provided that the marketplace cryptographically verifies each ART BLESS AMERICA owner's rights to display the Art for their ART BLESS AMERICA to ensure that only the actual owner can display the Art; or (iii) as part of a third party website or application that permits the inclusion, involvement, or participation of your ART BLESS AMERICA, provided that the website/application cryptographically verifies each Art Bless America owner's rights to display the Art for their ART BLESS AMERICA to ensure that only the actual owner can display the Art, and provided that the Art is no longer visible once the actual owner of the ART BLESS AMERICA leaves the website/application.

iii. Commercial Usage. Subject to actual owners of ART BLESS AMERICA continued compliance with these Terms, ART BLESS AMERICA grants you an unlimited, worldwide license to use, copy, and display the purchased Art for the purpose of creating derivative works based upon the Art ("Commercial Use"). Examples of specified Commercial Use would e.g. be the use of the Art to produce and sell physical merchandise products (T-Shirts, etc.) displaying copies and remixes of the purchased Art. Please note, as relates to Ownership nothing will be deemed to provide restrictions on the NFT holder including (i) owning or operating a marketplace that permits the use and sale of ART BLESS AMERICAs generally, provided that the marketplace cryptographically verifies each ART BLESS AMERICA owner's rights to display the Art for their ART BLESS AMERICA and provides verifiable evidence that only the actual owner can display the Art; (ii) owning or operating a third party website or application that permits the inclusion, involvement, or participation of ART BLESS AMERICAs generally, provided that the third party website or application cryptographically verifies each ART BLESS AMERICA owner's rights to display the Art for their ART BLESS AMERICA as a means to further ensure that only the actual owner can display the Art, and provided that the Art is no longer visible once the any owner of the Purchased ART BLESS AMERICA leaves the website/application; or (iii) earning revenue from any of the foregoing. Further, Digital-Galactic, LLC reserves the right to use ANY character, including derivative Artworks in any media of its choosing, including: print or digital advertising, or any purely creative media (including Anime, etc.) in support of the ART BLESS AMERICA community and message.

## COMPULSORY MECHANICAL MUSIC LICENSE

iv. A compulsory license is available to anyone as soon as phonorecords of a nondramatic musical work have been distributed to the public in the United States and its territories under the authority of the copyright owner. You may engage in the following activities with this compulsory license:

- Make and distribute a maximum of 500 digital cover copies of the eligible nondramatic musical work, where the primary purpose is distribution to the public for private use, including by DPD, and sold as NFTs.
- Authorize others to engage in the making and distributing of the digital covers.
- Make a musical arrangement of the work to the extent necessary to conform it to the style or manner of interpretation of the performance involved.

- Claim copyright protection in your arrangement as a derivative work.
