

PATENT APPLICATION ASSIGNMENT

WHEREAS, I, Eugene
(hereinafter referred to as "ASSIGNOR") am the inventor of an invention (the "INVENTION")
entitled:

that is the subject matter contained in Exhibit A, including the patent application referenced in Exhibit B, as attached hereto. ASSIGNOR hereby authorizes ASSIGNEE to insert the patent application number and filing date of said application into Exhibit B when known.

WHEREAS, MindMiner, Inc., is a corporation, organized and existing under the laws of the State of Colorado and the United States of America, having an office at 1600 Stout St., Suite 1100, Denver, CO 80202 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring the entire right, title and interest in and to said INVENTION, any patent applications containing said INVENTION (including the patent application referenced in Exhibit B), and in and to any Letters Patent that may be granted therefor in the United States and in any and all foreign countries (hereinafter referred to as the "INVENTION RIGHTS") for the purpose of allocating the INVENTION RIGHTS to the owner of a particular non-fungible token (NFT) designated to ascribe INVENTION RIGHTS to said invention to its owner;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is acknowledged, I, ASSIGNOR, hereby assign and transfer to the ASSIGNEE, its successors and assigns, my entire right, title and interest in and to the INVENTION RIGHTS, including the INVENTION, the patent application identified in Exhibit B, corresponding domestic and foreign applications, any continuation, divisional, renewal or substitute for the application, all Letters Patent, any reissue, re-examination, or similar legal protection issuing related to the Letters Patent, and all rights and benefits under any applicable treaty or convention; and I authorize the Director of the United States Patent and Trademark Office or foreign equivalent to issue the Letters Patent or similar legal protection to the ASSIGNEE.

ASSIGNOR hereby authorizes and requests the Patent and Trademark Office Officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to said ASSIGNEE, as the ASSIGNEE of ASSIGNOR's entire right, title and interest in and to the same, for the sole use and enjoyment of said ASSIGNEE, its successors and assigns.

As a condition of acceptance, ASSIGNEE shall undertake reasonable efforts to allocate ownership or exclusive license of the INVENTION RIGHTS to the owner of the particular NFT as described in Exhibit B, created by ASSIGNEE upon the direction of ASSIGNOR with the intent to allocate ownership of the INVENTION RIGHTS. Upon acceptance of this assignment and the creation by the ASSIGNEE of the particular NFT described in Exhibit B, ASSIGNEE hereby assigns and transfers to the owner of the particular NFT described in Exhibit B ASSIGNEE's right, title and interest in the INVENTION RIGHTS. ASSIGNEE further

covenants to assign and transfer ownership of the particular NFT described in Exhibit B to the ASSIGNOR or to the wallet address provided by the ASSIGNOR prior to the latest of the following dates and not earlier than the occurrence of all of the following: i. the date fourteen (14) days following the creation by ASSIGNEE of the particular NFT described in Exhibit B, ii. the date fourteen (14) days after the filing date of the patent application described in Exhibit B, iii. the purchase of exclusive rights to the INVENTION via the MindMiner platform by ASSIGNOR. ASSIGNOR hereby authorizes ASSIGNEE to insert in Exhibit B the identifying information of the NFT referenced in this paragraph into Exhibit B when known.

Further, ASSIGNOR agrees that ASSIGNOR will communicate to said ASSIGNEE, or its representatives, any facts known to ASSIGNOR respecting said INVENTION, and will testify in any legal proceedings, sign all lawful papers, execute all divisions, continuations, substitutions, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths and generally do everything necessary or desirable to aid said ASSIGNEE, its successors and assigns to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.

ASSIGNOR hereby covenants that no assignment, sale agreement or encumbrance has been or will be made or entered into which would conflict with this assignment.

ASSIGNOR hereby declares that all statements made herein of his or her own knowledge are true and that all statements made on information and belief are believed to be true, and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issued thereon.
