

DAO RESOLUTION

Date: Dated as of the related Executive Vote on Sky Ecosystem (formerly MakerDAO)

Purpose: Return of Funds from the RWA Senior Lending Trust Account

A. Reference is made to:

1. The Articles of Association of RWA International Ltd, dated February 2, 2021 (the “**Articles**”), pursuant to which the company’s operations are governed.
2. The Amended and Restated Trust Agreement, dated July 29, 2021 (the “**Trust Agreement**”), among Wilmington Savings Fund Society, FSB (“**WSFS**”), acting in its capacities as trustee (the “**Trustee**”), as verification agent (the “**Verification Agent**”) and as paying agent (the “**Paying Agent**”), and RWA International Ltd., as sponsor (the “**Trust Sponsor**”), with respect to establishing the RWA Senior Lending Trust (the “**Trust**”).
3. The Credit Agreement, dated July 29, 2021 (the “**Credit Agreement**”), between the Trust, as lender, and 6s Capital Partners, LLC, Series A (the “**6s Capital**”), as borrower, establishing a revolving credit facility of up to 15,000,000 DAI.
4. The Escrow Agreement, dated July 29, 2021 (the “**Escrow Agreement**”), among the Trust Sponsor, the Trust, and WSFS, as Escrow Agent, governing the custody and disbursement of funds held for the benefit of the Trust.

Capitalized terms used herein and not otherwise defined shall have the meanings given to them in the Articles, the Trust Agreement, the Credit Agreement, and the Escrow Agreement.

B. Whereas:

1. Pursuant to the Credit Agreement, the Trust extended a revolving credit facility of up to 15,000,000 DAI to 6s Capital.
2. On May 2, 2025, 6s Capital announced that it had fully repaid all amounts outstanding under the Credit Agreement and that such repaid amounts are currently held by WSFS in the Trust account (the “**Return Amount**”).
3. Pursuant to Clause 3.1(d)(ii) of the Trust Agreement, the Trust Sponsor is authorized and required to deliver instructions to the Paying Agent directing the distribution of Trust funds in accordance with the applicable payment instructions set forth in Exhibit D to the Trust Agreement.

C. Authorizations

In accordance with the governance protocols of Sky on the date specified above and pursuant to the Articles, this DAO Resolution approves and ratifies the following actions:

1. The Director of the Trust Sponsor is instructed to appoint Parallel Limited as exchange agent (the “**Exchange Agent**”) to facilitate the conversion of USD into USDC and the delivery of such USDC to Sky.
2. The Director of the Trust Sponsor is further instructed to deliver the attached [payment instructions](#) to WSFS and any other required agent to facilitate the transfer of the Return Amount to the Exchange Agent by wire transfer. For the avoidance of doubt, the Return Amount should constitute the full balance of funds held in the Trust account at the time of distribution, net of any applicable fees.
3. The Director of the Trust Sponsor is further instructed to direct the Exchange Agent to:
 - (a) convert the Return Amount, once received, into USDC; and
 - (b) transfer such USDC to the pause proxy 0xBE8E3e3618f7474F8cB1d074A26afFef007E98FB, the designated onchain address for Sky’s receipt of the Return Amount, net of any applicable fees.
4. The Director of the Trust Sponsor is authorized to take any and all other actions, and to execute and deliver any documents, agreements, notices, or instructions, as may be necessary or advisable solely in furtherance of the authorizations set forth in paragraphs C.1, C.2, and C.3 above.
