I. NOTICE OF LAWFUL STANDING

Pursuant to lawful authority and standing as a living man operating under Abrahamic Law—the highest jurisdiction on Earth which supersedes statutory, commercial, and maritime jurisdictions—I, Govinda Tidball, hereby serve final directive and notice to the Internal Revenue Service (IRS).

As of April 9, 2025, all rebuttal periods will expire, and the facts therein become final in law, commercial record, and divine jurisdiction. Your agency is now fully liable for all activities conducted under fraudulent financial assumptions, including the unauthorized securitization of birth certificates.

II. BASIS FOR THIS DIRECTIVE

1. **Fraudulent Financial Instruments:**

Birth certificates issued without the consent or signature of the father or mother have been securitized and used to extract value from living men and women without disclosure. This constitutes systemic fraud and violates international law, commercial codes, and natural law.

2. **Failure to Cure:**

The UCC-1 and UCC-3 filings, paired with the lawful Notice of Liability issued February 19, 2025, and returned uncured by the Texas Department of State Health Services - Vital Statistics (VSS), were served on all relevant parties including the U.S. President, U.S. Attorney General and Attorney General of Texas. Failing to cure or lawfully rebut, the IRS is now in commercial dishonor and complicit in a known, recorded, published fraud.

III. DIRECTIVE TO THE INTERNAL REVENUE SERVICE

You are hereby ordered to:

1. **CEASE & DESIST ALL COLLECTION ACTIVITIES:**

Effective April 10, 2025, any collection, enforcement, garnishment, audit, levy, or contact of any kind against the living is a willful act of fraud, misprision, and commercial trespass. This applies to:

- All voluntary and involuntary tax collections
- All attempts to compel filings, payments, or seizures
- All third-party enforcement actions via banks, employers, contractors, or agencies

2. **NOTIFY YOUR AGENTS AND CONTRACTORS:**

The Commissioner must immediately notify all IRS agents, officers, fiduciaries, and third parties that collection efforts post-April 9, 2025 constitute:

- **Misprision of Fraud & Felony** (18 U.S. Code § 4)
- **3x RICO Violations** (Racketeer Influenced and Corrupt Organizations Act)
- **Civil & Criminal Liability, Personal and Institutional**

Within ten (10) business days of this notice, you must:

- Prepare transfer protocols for all securities into **HONOR AND TRUST**, the lawful private trust designated for global redemption

- **Revocation of presumed jurisdiction**, both corporate and fiduciary

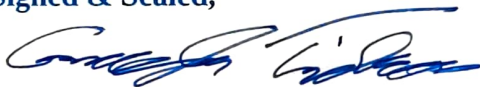
V. LAWFUL REDEMPTION HAS BEGUN
