1 Executive Summary

Vision

DAO STUDIO (DST) envisions a decentralized, AI-powered video ecosystem where creativity, ownership, and governance operate transparently and equitably. It transforms the centralized video-platform model — defined by opaque algorithms and limited creator control — into a **community-owned network** that rewards participation, contribution, and creative engagement in an open and verifiable manner.

DST empowers every member to **create, contribute, and participate in governance** through a self-balancing token framework that sustains liquidity, enforces scarcity, and supports continuous platform growth.

Mission

To build the world's first **AI-driven, DAO-governed media studio** that enables creators to produce and distribute content autonomously under a framework promoting ethical, family-safe content and long-term operational stability.

DST's mission:

“Create freely, contribute meaningfully, and govern collectively.”

Problem

Current video ecosystems are constrained by:

- Centralized decision-making and opaque visibility algorithms;
- Limited access to audience and engagement data;
- Ad-centric models that reduce creator autonomy; and

- Lack of governance participation for contributors who generate value.

This imbalance restricts both **creative independence** and **equitable participation**.
